**Opening Remarks: Mary Bethel,** Chair of the Board, opened the meeting at 10:01 a.m.

Minutes from the Oct. 22, 2021 meeting were unanimously approved with no changes.

**Finance:** Treasurer Dick Chady reported a checking account balance of \$74,928.06 as of Dec. 3, 2021. The report was accepted.

Legislative Update: Heather listed highlights from the new, two-year \$53 billion budget:

- It has many positive things for older adults. We saw significant activity in all five of NCCOA's five critical priorities and our seven points for most vulnerable and growing populations.
- Although we still need action to improve voting for residents of long-term care facilities, Disability Rights NC has filed lawsuit on that issue.
- Even though the budget did not include full Medicaid expansion, the legislature did extend Medicaid coverage for new moms up to 12 months postpartum, as well as authorizing an 18member legislative study commission on full expansion.
- $\circ$  The NCGA will reconvene Dec. 30 for limited issues.

Budget highlights by NCCOA priorities:

- Removes the reimbursement cap for adult day service providers.
- Stabilizing the direct care workforce crisis.
  - Provides a one-time bonus of up to \$2,000 per worker; \$102 million in state funds for raises to workers in Home and Community-based services over two years; raises up to \$15/hour for ICF/IIDs.
  - Increases support for home and community-based services.
    - Provides \$5.7 million to reduce the Home and Community Care Block Grant waiting list by 1,500 slots.
    - Expands the Community Alternative Program for Disabled Adults (CAP/DA) by 114 slots.
    - \$11 million for more slots for several Medicaid waiver programs.
    - Increases the Medicaid rate for private duty nursing to \$45/hour.
    - \$15 million for another 1,900 Medicaid recipients under the State-County Special Assistance In-Home programs.
    - \$1.1 million to transition persons with mental illness from institutions to communitybased settings.
- Restores \$50 million for Rural Operating Assistance Program (ROAP) and State Maintenance Assistance Program (SMAP)
- o \$2.6 million in federal funds for Adult Protective Services.
- Increases the Personal Needs Allowance for Special Assistance recipients in adult care homes to \$70 from \$46 in 2022.
- Unfinished Business The Coalition will need to continue working on the following priorities:
  - Remove voting barriers for residents in group care settings.

• Increase access to health care by expanding Medicaid.

• Undertake a comprehensive study to address the challenges and opportunities of North Carolina's increasing older adult population.

- Invest additional state dollars in Adult Protective Services.
- Increase the Personal Needs Allowance for residents living in nursing homes.

• Increase wages for direct care workers in adult care homes and skilled nursing facilities

## **Member Comments**

- Jeff Horton of the NC Health Care Facilities Assn: Their industry behind the move to make in-home Medicaid rates more comparable to facility-based ones.
- Linda Kendall Fields: CARES UNC Chapel Hill; will offer grants for up to \$150,000/year for innovations in housing, transportation, direct care workers for adults with disabilities and older adults.
- **David Rhew** NC Transit thanked NCCOA for its efforts in increasing transportation funding.
- Tom Goldsmith of NC Health News asked for information on how many seniors have been moved from adult care homes to community facilities under the NC Disability Rights lawsuit settlement. Kathie Smith of the Assn. of Home and Hospice Care recommended checking Brad Owen in NC DHHS re a pilot program.
- **Heather:** NC DHHS will release the Olmstead plan in 2022 to improve opportunities for people with disabilities to live in the community. We have provided comments.

Adult Protective Services: Rebecca Freeman of NC DAAS explained that the budget allocates \$43.4 million from American Rescue Plan:

- Title III-B: Supportive Services \$14.2 M
- Title III-C: Nutrition \$16.9 M
- Title III-D: Evidence-Based Health Promotion \$1.4 M
- Title III-E: Family Caregiver

Support \$4.4 M Title

- VII: Long-Term Care Ombudsman \$300 K
- AAA Planning & Administration \$4 M
- State Administration \$2.2 M
- o State budget \$75 mi

Sarah Richardson of NC DAAS detailed their Adult Protective Services Improvement Plan. Its four goals:

- 1. Consistency of practice
- 2. Community stakeholder engagement
- 3. Community education
- 4. Statutory improvement

## **Director's Update by Heather:**

- Z. Smith Reynolds Foundation has given us a two-year, \$60,000 grant for advocacy regarding the direct care workforce, particular for communities of color, women. The board will develop the specifics on goals and milestones.
- We welcomed six new members since October.
- Supporters donated \$260 for NCCOA's first #GivingTuesday.
- Intern Madeline Rickett completed the stakeholder survey and will make a report. In January, she'll start membership Spotlights on @NCAging Twitter.
- Work groups: **Family Caregiver Work Group.** We have partnered with the Caregiver and Patient Engagement Work Group of the NC Serious Illness Coalition to bring collective efforts together to support family caregivers.
- Health Equity Committee: Daryl Davis Fulmer and Laura Schlabach will co-chair. SAGE will do a webinar and training. The NCDHHS Chief Health Equity Officer Victor Armstrong will join us at a future membership meeting.
- Heather thanked the NC Alliance for Health for hosting her on a podcast on resilience.
- Heather will appear on a policy forum on Facebook live arranged by Lisa Riegel of AARP on December 3, 2021.
- Heather thanked **PHI** for helping to create Essential Jobs, Essential Care NC project. Our work to spotlight this issue had a positive effect in the recent NCGA session.

## **Sharing by Coalition Members**

- **Roger Manus** from Governor's Advisory Council on Aging looking for areas to cooperate. They offered a short survey re possible collaborative efforts.
- **Gina Upchurch** of Senior PharmAssist Asked people to be aware of possible cutbacks in networks in Medicare Advantage plans when some persons become sick.
- NC Bar Assn reported a goal for reforming the NC guardianship program (Section 35-A of the NC laws) in 2023.
- Ben Popkin of Popkin Strategies asked to focus attention on visitation over the holidays.
