## PERSONAL NEEDS ALLOWANCE (PNA)

The Personal Needs Allowance (PNA) is the monthly sum of money that residents who receive Medicaid may retain from their personal income. This money can be used to purchase needed products such as specialty shampoo and toiletries, underwear, over the counter meds, snacks, etc.

For assisted living residents, PNA is \$70 a month which was increased in 2022 (it was \$46, a change made in 2003).

In 2023, we successfully advocated for an increase for Nursing home residents. PNA was increased from \$30 a month to \$70 a month. This was effective 1/1/24.



#### Personal Needs Allowance increase for nursing home residents passes and becomes law in North Carolina!

## **2024 Policy Priorities**

1. Study and promote implementation of a comprehensive Medicaid rate and wage analysis to address current and future demand for long term care services and support.

2. Strengthen the state's Long Term Care Ombudsman Program to sustain quality long term care in our state. This includes exploring how to best define the roles and responsibilities of the Community Advisory Committee volunteers within North Carolina's ombudsman program and addressing staffing concerns associated with paid ombudsman positions.

3. Define a portion of Medicaid reimbursement to support the direct care workforce in long term care services and supports. This will ensure that money that is intended to go to wages for direct care workers is enforced and goes directly to workers.

4. Enhance available information about ownership and related party beneficiaries for long term care facilities receiving public support.

5. Participate in the adult care home accreditation demonstration and ensure resident and family perspectives are heard.
